1. Two \$1500 scholarships for students currently enrolled in Electrical Power Distribution program.
2. To be eligible for a scholarship, the applicant:
 - a. Must have completed at least first semester.
 - b. Must be currently enrolled for 12 credits or more.
 - c. Must complete application form.
 - d. Meet high academic standards in the program.
 - e. Must be a resident of counties served by ACEC, preference will be given to members of the cooperative. The counties include Adams, Columbia, Dane, Portage, Dodge, Green Lake, Jefferson, Marquette, Sauk, Waupaca, Waushara, and Wood.
3. The scholarship recipient will be notified by mail.
4. All information provided in this application will be handled in a professional and confidential manner by the scholarship committee.
