Alliant Energy – Going Green

I have mentioned our partnership with the West Riverside Project several times this past year. I would also like to mention that Alliant Energy, our wholesale power provider, is taking steps to add more wind farms to their energy operation. Alliant currently owns six wind farms that have a combined potential outcome of 1,038 megawatts of power.

Alliant Energy's goal to reduce carbon emission by 40 percent by 2030 will be underway with construction of two new wind farms in Wisconsin and Iowa. These projects combined will cost an estimated \$2 billion and are expected to be completed in 2020.

How does this affect you? Well, not only is it reducing emissions, making our environment better, but it will also help keep our wholesale energy costs from rising in the long run. Our members have expressed a desire to hear more about ACEC's renewable efforts, and we want you to be aware that ACEC and our partners are constantly exploring new green projects.

emember a few months ago when we talked about Patronage Capital Allocations? Allocations the amount that represents your ownership in the cooperative. The board of directors has now approved the 2018 retirement amount. They have examined our co-op's financial needs and determined the amount that can be returned to members this year—aka patronage capital retirements.

You probably also remember that cooperatives are not-for-profit organizations, and you've heard us talk about member-owners. That's you! You are a memberowner. ACEC does not exist to generate funds for shareholders. The funds that the co-op takes in for the year are used to pay for the wholesale power we purchase, materials like poles and wire, and operating costs. The board of directors reviews these numbers and allocates margins back to the members in the form of patronage capital. As the financial condition of our cooperative permits, a portion of this patronage capital is refunded to you.

Who gets a refund?

For 2018, your board of directors voted to use a "first in, first out" retirement schedule. Meaning, members with an allocation balance in the oldest remaining years will receive a patronage capital

retirement (refund). This year, retirements totaling over \$2,053,000 will be distributed to those with allocation balances in 1996, 1997, 1998, and a portion of 1999. If you are an active member who falls into this category, you will see a refund on your July electric bill. However, if your refund is more than \$150 you will be mailed a check. For those of you who know inactive members, they may also receive a check if their retired patronage totals over \$10. If their refund is less than \$10, the patronage will be held until the total retired amount is over \$10, and then a check will be processed.

What if the member is deceased?

The patronage capital is transferred to the member's heirs. If you are an heir or a personal representative of the decedent's estate, please contact our office and an Adams-Columbia staff member will advise you on the process to claim the patronage.
