Educational Scholarship

STEM Grant

In January we kicked off our STEM grant program. This program allows educators to apply for a grant up to \$500 for their classroom in the field or studies of Science, Technology, Engineering, and Math. The funding for this grant comes from the *Federated Youth Foundation.

*The Federated Youth Foundation is a 501(c)(3) nonprofit organization. The funds come from unclaimed patronage capital. As stated in ACEC's bylaws, after three years unclaimed patronage capital rolls over into the Federated Youth Foundation. These funds must be used for educational purposes or other charitable options approved by the board.

Operation Round-Up

ACEC members can apply for funds for local projects and charities within our service territory. Examples are emergency assistance following natural disasters, youth programs, civic projects, and more. The funding for this program comes from members who voluntarily "round up" their electric bill and contribute a few cents every month. All funds are maintained separately from Adams-Columbia's operating finances and are overseen by a committee made up of ACEC members from each of our seven districts.



BEWARE OF PHONE SCAMS



Unfortunately, in today's world, scams are inevitable. Scammers can threaten you with everything from legal action involving the IRS to turning off power to your home.

Utility scams often involve an individual or group posing as an employee of your electric cooperative. The scammer may use threatening language in order to frighten you into offering your credit card or bank account information. Don't fall victim to these types of scams. Understand the threats posed and your best course of action:

• If someone calls your home or cell phone demanding you pay your electric bill immediately, gather as much information as you can from that individual, hang up the phone, and contact the local authorities. Scammers often use threats and urgency to pressure you into giving them

Jay A. Porter, PE-CEO Ashley Miller-Editor your bank account number or loading a pre-paid credit or debit card (such as a Green Dot card). Adams-Columbia will never ask you to offer up personal finance information over the phone.

- A new scamming technique called "neighbor spoofing" is very popular right now. Con artists are using technology to change what phone numbers are appearing on caller ID—making it look like the call is coming from a local phone number or business. Unfortunately, several members have called letting us know they have received one of these calls. If you are questioning the legitimacy of a call from the co-op, hang up and re-dial 1 (800) 831-8629.
- If someone comes to your home claiming to be an employee of Adams-Columbia who needs to collect money or inspect parts of your property, ask for ID or call us to verify the person is, in fact, an employee. If they are not, call local authorities for assistance and do not let the individual into your home.

There are other types of scams consumers should watch out for:

- Government agencies like the IRS will never call to inform you that you have unpaid taxes or other liens against you. You will always receive this type of information in the mail. If someone calls claiming to be the IRS, hang up immediately.
- If you receive an email from an unknown sender, an email riddled with spelling errors and typos, or an email threatening action unless a sum of money is paid, do not click any links provided within the email, and do not respond to the email. Simply delete the email, or send it to your spam folder.
- If someone calls your home claiming to have discovered a virus on your computer, hang up. This caller's intent is to access personal information you may be keeping on your computer.

Adams-Columbia wants to make sure you avoid any and all types of scams that could put you or your financial information in jeopardy.
