# POLICY CHANGES AND OTHER ISSUES

Each year we review rates and our Rules and Regulations and update them as needed. You may be wondering what ACEC's Rules and Regulations is. This detailed document outlines how the board of directors believes we should operate the cooperative. All policies are intended to keep the cooperative running in the best interest of the members and the cooperative as a whole.

There are a few changes to the Rules and Regulations for 2020. They include updated fees for service work, an updated way of calculating new electric services and facility retention fees, and a revision to deposits. You can find the Rules and Regulations on our website.

I am pleased to say there are no overall rate increases forecast for 2020, and this fall we will be offering new rate options for members. Watch for more information in coming publications.

#### **Deadlines**

**Scholarship:** The deadline to apply for the 2020 Educational Scholarship is February 14. Adams-Columbia has been awarding this scholarship for over 30 years. **Advisory Resolutions:** If you would like to bring a matter in front of the membership at the annual meeting in May, your advisory resolution must be submitted by Friday, February 21, to allow time for the Rules Committee to review and research your request.

# WHO IS ON THE BOARD?

The board is made up of nine cooperative members, one from each of our seven districts and two At-Large positions.

# WHAT DOES A DIRECTOR DO?

A director represents all members of ACEC and is responsible for approving general policies, annual budgets, special contracts, patronage capital retirements, bylaw amendments, rate schedules, and delegating authority to the CEO to execute and carry out the daily activities of the cooperative.

## WHEN DOES THE BOARD MEET?

Regular meetings are held the last Wednesday of each month at the co-op. In addition to regular board meetings, directors rotate to attend occasional regional and national meetings as well as educational seminars.

## IS THERE ANY COMPENSATION?

Directors are paid a per diem for each meeting attended, as well as IRS-approved mileage.

# IS THERE A TIME COMMITMENT?

From monthly board meetings to ACEC's Annual Meeting, trainings, member events, workshops and travel, the typical time commitment for board members is approximately 18-24 days/evenings per year. Directors spend additional hours reading industry-related materials and news to stay abreast of policy trends and information.

# GETTING ELECTED:

Per ACEC's bylaws, interested members must follow our Nomination by Petition process. Members need 25 signatures from any ACEC member in any district (one signature per membership). The deadline to submit petition papers is February 21, 2020. Candidates are then voted for at the Annual Meeting, voting in person, electronically, or by absentee ballot.

### Board Meeting (includes budget meeting) Summary November 26, 2019

The workplan/budget meeting of Adams-Columbia Electric Cooperative was held at the cooperative's office in Friendship, WI on Tuesday, November 26, 2019, at 9:06 a.m.

Meeting began with the Pledge of Allegiance followed by Director Gibeaut's invocation.

A Safety Message was provided by Director Alexander.

All directors were in attendance. The agenda was approved as sent.

**General Manager Report:** Porter opened the meeting by acknowledging the staff and thanking them for their efforts on the 2020 budget.

Finance Manager West presented the comparative capital budget, statement of operations, and the 10-year financial forecast. He noted no rate increase anticipated despite slow growth in services and only a 2% increase in operation costs, keeping margins well within the financial policy guidelines.

Board approved the 2020 Workplan/Budget as presented and the Federated Youth Foundation educational and charitable anticipated 2020 grants.

The budget meeting was adjourned at 11:35 a.m.

# Chair Gibeaut called the regular board meeting of Adams-Columbia Electric Cooperative to order at 11:40 a.m. on Tuesday, November 26, 2019.

Following is a summary of the meeting activities.

The agenda, consent agenda items, board expense vouchers, and the minutes of the October 30, 2019, board meeting were approved.

Director Reports: Several board members had favorable member interactions.

Financial Review Committee: The Financial Review was completed by Ebert, Gibeaut, and Olson, noting no further review necessary.

#### **Board Action Items:**

- The next board meeting will be Monday, December 30, 2019, at the Friendship office.
- The 2020 board meeting schedule was reviewed. The Education and Lobby Days are being held in Madison on January 28 and 29, 2020, so the January ACEC board meeting will be held the afternoon of Wednesday, January 29, 2020, at 1 p.m. at the Pardeeville Service Center.
- Board in agreement to leave the District 5 position open rather than appoint a member as there is insufficient time between now and election in May 2020. Gibeaut noted that District 5 is still being represented by all the directors.
- Board approved the Resolution of Appreciation for Kendal Nichols.
- Vedder distributed information on advisory resolutions and voting at the annual meeting and this topic will be added to the December meeting agenda.
- CFC Representative Sarah Bullock will facilitate the 2020 Strategic Planning Session on June 24 and 25, to be held at the Friendship office.
- Alexander noted that the Operation Round-Up committee granted a request for a community Thanksgiving meal, suggesting other community groups should apply for funding.
- · Board approved a Christmas bonus for all employees.
- Gibeaut and Hoernke will attend the upcoming NRECA BLC #953.1: Improving Board Decision Making Quality training.
- Upcoming conference attendees are:
  - Gibeaut and Hoernke to attend the NRECA Annual Meeting on March 1-4, 2020, in New Orleans;
  - Fahey and Hoernke to attend the NRECA Legislative Conference on April 26–28 in Washington, D.C.;
  - Vedder to attend the CFC Forum on June 15–17 in Salt Lake City.

**Departmental Reports:** Monthly financial statements and departmental reports were reviewed. The rate structure will be reviewed at the December meeting.
