Our office will be closed December 24, 25 and January 1.



BOARD SIZE & ANNUAL MEETING INFORMATION



With the 2021 director election, we would see District 1, District 6 and an At-Large seat up for election. With these directors choosing not to run for another term, the board determined the time was right to resize and redistrict. As of the May 2021 Annual Meeting, the board will consist of seven districts with no at-large seats. With the new district lines drawn, District 1 and 2 will be up for election at the 2021 meeting.

DIRECTOR QUALIFICATIONS AS CITED IN THE BYLAWS:

- To be a full-time resident and member in good standing in the director district from which he or she has been nominated.
- Cannot be employed by or financially interested in a competing enterprise or business selling energy or supplies to the cooperative.
- Cannot have been in default on any obligations to the cooperative in the preceding 12 months.
- Cannot have been employed in any capacity by the cooperative within five years of the date of the election.
- Cannot be an incumbent of, or candidate for, an elective county, state, or federal office filled by election on a party ticket.
- To have not been convicted of any felony or of any other offense involving a breach of trust.

WATER HEATER PROGRAM

After much evaluation, we have decided to discontinue the sale and installation of water heaters effective January 29, 2021. The number of installs over the last few years has steadily declined and we simply cannot compete with the pricing and offerings from big box stores.
