Please keep us updated if your contact information changes. It's important that we have your correct information on file. We may contact you if we have a planned outage in your area, have a question about your service or need to contact you for billing purposes.

Be sure to keep your information up to date with us if you move off of our lines as well. As a member of a cooperative, you will accrue patronage capital based on the amount of electricity you use at your service. Patronage capital gets returned back to you over time.

You can expect patronage capital allocations in the spring each year to let you know how much you have accrued so far. Patronage capital retirements (refunds) are typically processed in the fall each year. Visit our website to learn more about patronage capital.



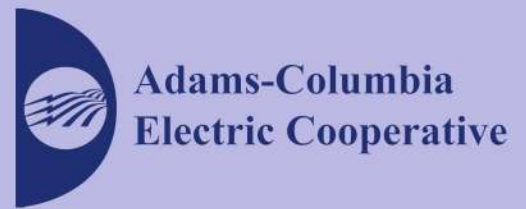
SmartHub is your online portal to manage your ACEC account(s). Download the free SmartHub app on your mobile device through the App Store or Google Play Store.
