SAFETY MESSAGE

As you prepare for hunting season, keep in mind that along with general hunting safety, electrical safety should also be top of mind. Please report any damage to a line or other related equipment to us so that we can address it. Although we perform routine maintenance, damage may not be noticed for weeks or months unless an outage occurs due to the vast amount of lines that cover our service area.

- Do not use power poles to support a tree stand.
- Do not locate a tree stand near a power line or pole.
- Take note of power lines and equipment, especially when hunting in densely wooded areas.



AMISH STYLE BREAKFAST CASSEROLE

PREP TIME - 30 MINS | COOK TIME - 30-45 MINS

INGREDIENTS

- 1lb sliced bacon
- 1 medium onion, diced
- 1-2 cloves minced garlic
- 8 eggs, beaten
- 1/2 tsp salt

- 1/4 tsp pepper
- 24 oz thawed shredded hash browns
- 2 c shredded cheddar cheese
- 12 oz small curd cottage cheese
- 6 oz shredded swiss cheese

INSTRUCTIONS

- 1. Preheat the oven to 350 degrees. Prepare a 9" x 13" baking pan by lightly spraying with cooking spray.
- 2. Dice bacon. In a large skillet, combine the bacon and onion and cook until the bacon is crisp. Drain the bacon. Return the skillet to the stove and add minced garlic. Stir for about one minute or until fragrant. Remove from stove.
- 3. In a large bowl, mix the remaining ingredients. Stir in the bacon mixture. Transfer to the prepared baking pan.
- 4. Bake uncovered for 35-40 minutes or until a knife inserted near the center comes out clean. Let stand for five minutes before serving.



RATE INCREASES FOR GENERAL SERVICE

EFFECTIVE 1/1/2025

In September the board of directors approved a rate increase for general service rates. As a cooperative, we're a not-for-profit organization, meaning that we only charge you enough to operate the cooperative. Knowing the financial pressures impacting our membership in all facets of life, this decision was not made lightly.



Over the past 3 to 4 years, inflation prices have impacted every area of our business resulting in the need for this rate increase. We've seen extreme increases in the cost of equipment, materials, and an increase in both wholesale energy and demand.

We've evaluated and adjusted our commercial rates as our wholesale power costs have increased, and with the completion of the cost of service study, we now also need an increase in our residential rates.

Rate increases will impact the facility charge and kilowatt-hour (kWh) charges, and second meter charge for members with two meters, effective January 1, 2025.

GENERAL SERVICE TIME-OF-DAY RATE

For members on our time-of-day rate, the kWh charge for each peak period will be increasing. The time frames throughout the year will stay the same.

All rate details will be published on our website as we approach the new year. We encourage members to review the energy assistance and Focus on Energy details in this newsletter to save money where possible.

WHAT ACEC IS DOING TO MINIMIZE THE RATE IMPACT:

We have taken several steps to mitigate expenses that are in our control. Areas that have been heavily evaluated include:

- The size of our fleet
- The equipment we use
- Office supplies and material expenses
- Expensive projects being delayed or canceled

LAST TIME ACEC INCREASED GENERAL SERVICE RATES:

We've been able to maintain our general service rates without an increase or adjustment in **six years**, thanks to our investment in West Riverside Energy Center and other cost-saving measures.

2017
Facility Charge increased from \$1.0288 to \$1.08

2018
Kilowatt-hour increased from 10.5¢ to 11.2¢

We often get compared to investor-owned utilities in our area when it comes to rates. For comparison, we serve about 7 members per mile of line and investor-owned utilities serve about 27 customers per mile of line, meaning they have more customers to split their costs amongst.

In the early 1900s, investor-owned utilities didn't want to serve rural areas, which led to the movement of the Rural Electrification Administration in 1936 and the formation of electric cooperatives.


